#### **INSTRUCTIONS FOR USE**

STEPS	INSTRUCTIONS FOR EACH STEP		
Step ONE	Select a topic from "Bible stories on Sin, Punishment, Confession and Repentance" (p4). As an example, I'll select #84, THE MARK OF THE BEAST.		
	Get familiar with the types of questions.		
	Comprehensive set of questions (p6): These questions cover the entire process from the temptation to the aftermath.		
	Questions on warnings (p7): These questions hone in on the matter of the warning before the sin was committed.		
Step TWO	Questions on the temptation and motive (p8): These questions focus on how the subject succumbed to the temptation and how to avoid it.		
(pp6-12)	Questions on the sin (p9): These questions focus on the type of sin.		
	Questions on the punishment (p10): The punishment pertains to how God punished on the one who sinned.		
	Questions on a confession and repentance (p11): For the stories that have a clear cut version of confession and repentance, this process is analyzed		
	Questions on the lesson learned (p12): This topic pertains to whether the sinner learned their lesson.		
Step THREE	Read the account in the Bible. In this example, you would read Rev 13:16-18; 14:10-11; 16:2 and possible cross references.		
Step FOUR	Select an appropriate set of questions, and then plug in the questions. As an example, I'll select SET OF QUESTIONS ON THE WARNING.		
	Begin to answer the questions from the set of questions you selected.		
Step FIVE	For example, QUESTION #3, "How was the warning issued?" ANSWER: In Revelation 14, an angel is depicted as the one issuing a very strong warning. A vernacular application may mean that ministers in that day will preach against the mark of the beast.		
	For example, QUESTION #19, "Can you discuss the concept of a warning in light of John 9:41??" ANSWER: Those who take the mark of the beast wi have had a very, clear warning issued to them. This punishment will be the harshest ever. There will be very, strong deception, but it won't be a tric		
	The teacher can select which questions the students need to answer. Students should come to class well-prepared for a vibrant discussion.
